Terms& Conditions of AMC

- 1. AMC will be affected from 15/01/2015 ending on 14/1/2016.
- 2. Before awarding contract to successful bidder, a Performance Security amounting to Rs. 5000/- would be required to submitted by him in the form of Account Payee Demand Draft, Fixed Deposit Receipt, Banker's cheque or Bank Guarantee from any of the commercial banks in an acceptable form. Performance Security should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the firm.
- 3. The contract will be Non-Comprehensive. The cost of spare parts replacement will be borne by this office i.e. only service alongwith Preventive maintenance has to be taken up by the firm.
- 4. The firm should have successfully undertaken similar work in Govt. Department/ Ministries. Copy of Experience /AMC awarded by other Ministries/Departments may be attached in Technical bid.
- 5. The firm should have Work Contract Certificate registered in their name for computer maintenance.
- 6. The firm should have PAN allotted to them by the Income Tax Department.
