

1. Bids will be opened on the 12th October 2020 at 4.30 p.m.
2. Items are being offered as a whole lot not as individual. Bidders have to take all the dead items (complete e-waste) and therefore selection of specific item is not available.
3. Further bidders have to arrange for the pickup of these items from the O/o CAC, No cartage charges whatsoever will be paid. Labour etc. to be arranged by the firms.
4. Bidders will be allowed to inspect all the auction items on 'as and where basis' on 8th and 9th October 2020 from 02.00 p.m to 5.00 p.m.
5. Auction will be awarded to the bonafide firm who will quote the highest price of the items taken as a whole.
6. Successful bidder (ref item 5 above) will have to make complete payment (as quoted by him in his bid) in Cash or by Demand draft payable locally in favour of "SO & DDO", O/o Chief adviser Cost. **Firms will be allowed to take goods only after making complete payment.**
7. The firm should have PAN allotted to them by the Income Tax Department.
8. The firm should provide a certificate that "Firm will not misuse any data which is available/ saved in the hard disk of the dead computers and will delete them if extractable. Further the electronic waste should be disposed off in the eco-friendly manner if not used by the firm as per the extant guidelines of Ministry of Environment & Forest. Prospective bidders of such lots of hazardous waste/scrap batteries/ e-waste should be in possession of registration, valid on the date of e-Auction and on the date of delivery, as recycler/ pre-processor agency." This office of CAC will not be liable for any of the harm whatsoever caused to the third party due to use of these e-waste items.
9. Rates quoted should remain valid for a period of 30 days from the due date of tender. Rates to be quoted in figures as well as in words without any overwriting. Any correction should be stamped and signed.
